

Repurchase and sale of shares in the context of the liquidity contract Period from 3 January 2022 to 7 January 2022

This press release is published in application of the circular FSMA/2019_26 of 11 September 2019.

Within the framework of its liquidity program ([see press release of 5 October 2020](#)), Befimmo reports today the purchase of 10,125 shares on Euronext Brussels during the period from 3 January 2022 to 7 January 2022. In the same period Befimmo sold 13,019 shares.

The balance held by Befimmo under the liquidity contract at the end of the period is 38,449 shares. On 7 January 2022, Befimmo owns 1,431,977 own shares out of 28,445,971 issued shares (or 5.03%).
