

Repurchase and sale of shares in the context of the liquidity contract

Within the framework of its liquidity program ([see press release of 5 October 2020](#)), Befimmo reports today the purchase of 10,264 shares on Euronext Brussels during the period from 10 January 2022 to 14 January 2022. In the same period Befimmo sold 13,712 shares.

The balance held by Befimmo under the liquidity contract at the end of the period is 35,001 shares. On 14 January 2022, Befimmo owns 1,428,529 own shares out of 28,445,971 issued shares (or 5.02%).
